#### Clinical Component Update Welcome to the New Assistant Director!

**Dr. Eric Crawford** recently joined our MIRECC to work with Dr. Kudler as the new Assistant Director of the Clinical Component. In the five years prior he served as a staff psychologist at the Durham VAMC, coordinating and providing psychological services to Veterans recently returned from conflicts in Iraq and Afghanistan with stress-related disorders, TBI, and other post-deployment mental health conditions.

Dr. Crawford (on right in picture) maintains a clinical specialization in empirically supported treatment of PTSD. He is a trainer for VA's National Dissemination of Prolonged Exposure Therapy for PTSD, providing didactic instruction and consultation to VA clinicians and local trainees seeking to learn this evidence-based treatment. He has authored multiple publications in this area, and has participated on two randomized controlled trials evaluating augmentation of existing treatment for chronic PTSD. He is also an Assistant Clinical Professor in Duke's Department of Psychiatry and Behavioral Sciences. Dr. Crawford's current research



interests are wide ranging. They include the effectiveness of Prolonged Exposure Therapy in special populations characterized by medical and psychiatric challenges such as TBI or substance use disorders, patterns of help-seeking and healthcare utilization in returning veterans, pathophysiology of PTSD, and patient-level or systemic factors that impact engagement with mental health services. Dr. Crawford is tremendously excited about the opportunities associated with his new position in the MIRECC Clinical Component, and feels strongly that it provides an ideal fit for his set of clinical, research, and educationrelated skills.

## Outreach to Providers: Group Supervision for Clinicians Listening to Trauma Histories

Therapists treating PTSD often find themselves in parallel turmoil, as they react to the patient's inner and outer worlds. Good clinical supervision is essential. In addition to receiving guidance and support from an experienced colleague, having the opportunity to share one's often turbulent emotions and learning how these can be used to better understand the case are also important.

**Purpose:** Assist presenter in processing a case that is particularly disturbing and hard to let go of.

Audience: Trauma clinicians and staff who routinely hear disturbing trauma histories

Recognize the potential effects of trauma narratives on therapists and staff;

Identify the importance of on-going clinical supervision in work with trauma
