The VA Advanced Fellowship Program in Mental Illness Research and Treatment at the Capitol Health Care Network (VISN 5) Mental Illness Research, Education, and Clinical Center (MIRECC) has two 2-year fellowship positions: one position for a **Physician Fellow** from psychiatry, neurology, radiology, internal medicine, or other areas of medicine and one position for an **Allied Health Fellow** from clinical psychology, counseling psychology, social work, nursing, or pharmacy.

Our program trains fellows to become successful researchers whose work increases access to effective mental health services for all Veterans who need them. We are clinician researchers who are committed to innovative applied research and resource development. Our research program addresses some of the most important mental health services research priorities within VA for Veterans with mental illness: improving the quality of care, increasing access to effective treatments, overcoming barriers to implementation, using cutting-edge methods to understand needs system-wide, and working towards reducing suicide through better identification of and engagement with those at highest risk.

Fellows develop **independent programs of research** that address these and other high priority areas. We actively mentor and support fellows in writing and obtaining mentored early career investigator awards including VA Career Development and NIH K Awards (6 awards in the last 7 years) in areas of great importance to VA and Veteran mental health. Fellows devote time to supervised delivery of mental health services, both to identify important clinical questions and to experience the challenges and successes related to **translating scientific findings into their practice**. Didactic offerings offer focused learning in biostatistical methods, health informatics, and grant writing alongside opportunities to develop and apply knowledge to support the **recovery of people living with mental health conditions**. Fellows spend approximately 65% of their time in research-related research and clinical activities, 25% in clinical service and training activities, and 10% in didactic and administrative activities.

Established in 2003, we are part of the national VA Advanced Fellowship Program in Mental Illness Research and Treatment. Our Center is located at the Baltimore VA Medical Center and is affiliated with the University of Maryland School of Medicine, making it an outstanding collaborative and interdisciplinary setting. **Candidate Requirements.** A successful candidate will have graduate training in applied research in mental health and recovery, will have actively participated in research with resultant presentations and publications, will demonstrate a commitment to the scientist-practitioner model, will have training in empirically supported treatments for mental illness, and will demonstrate a commitment to serving Veterans. We are especially interested in applicants who want to develop health services research in the following topics related to serious mental illness: aging, pain, sleep and circadian science, stigma and treatment engagement, and measurement-based care.

Physician applicants must have completed ACGME-accredited training, be board eligible or board certified, and have an active, unrestricted U.S. license to practice. International medical graduates must also have a current visa and an ECFMG certificate that is valid indefinitely. Applicants on a J-1 visa must also have current ECFMG sponsorship. Eligible psychologists and allied health professionals must be U.S. citizens. Psychologist applicants must have graduated from an American Psychological Association (APA) or Canadian Psychological Association (CPA) accredited doctoral program in clinical or counseling psychology (or be on track to complete graduate training prior to beginning fellowship) and must have completed an APA- or CPA-accredited internship. **Application Procedures.** Applications are being accepted through December 5, 2025. Psychologist applicants should submit materials through the APPA CAS portal (<http://appic.org/AAP/APPA/Postdoc-Application-Information>). All other applicants should email these materials directly to Drs. Bennett and Klingaman ([Melanie.Bennett@va.gov](mailto:Melanie.Bennett@va.gov); [Elizabeth.Klingaman@va.gov](mailto:Elizabeth.Klingaman@va.gov)). All applicants should submit (1) A letter of interest that outlines career goals, research interests, and goodness of fit with our program; (2) A current curriculum vitae; (3) A research statement that reviews their interests, experience, and ideas for developing a program of research that fits with the scope of our center; (4) Official graduate transcripts; (5) A signed letter from their graduate program that lists date of dissertation proposal, anticipated or actual date of dissertation defense, and anticipated or actual date of graduation; (6) Three signed letters of recommendation (for psychologist applicants, one letter must be from an internship supervisor). We will review completed applications and extend interview invitations during late December 2025 and early January 2026. Interviews can be done virtually or in person. Applicants meet with the program directors and complete group interviews focused on fit with the program and research interests/planning. Applicants can request investigators to speak with if they have a preference. Applicants are also scheduled for a meeting with a current fellow. Offers will be extended in late January and early February 2026.
