



CAVHS is a large and complex VA Medical System that is academically affiliated with the University of Arkansas for Medical Sciences (UAMS). CAVHS is located in a metropolitan area of approximately 580,000 people and draws from a primary service area of 275,000 Veterans. The consolidated, tertiary care medical center provides medical, surgical, psychiatric, rehabilitation, and nursing home services, as well as a wide variety of outpatient, specialty and primary care programs at two large medical facilities and several community-based outpatient clinics throughout the state. CAVHS offers a wide range of clinical training opportunities in mental health and serves as a training site for numerous clinical training programs based jointly at CAVHS/UAMS.

CAVHS/UAMS also offer a very rich environment for research and clinical administration training. The researchers and faculty working in these areas represent one of the largest and most successful groups of mental health services researchers in the U.S. Also the SC MIRECC collaborates with investigators at its “anchor sites” in Houston and New Orleans. These resources create an ideal environment for trainees interested in becoming independent researchers or clinical leaders in academic medicine, Veterans affairs, or university environments.

## **VA Advanced Fellowship Program in Mental Illness Research and Treatment**

Post-Residency Training For Physicians

**Little Rock, Arkansas**

## Overview

The VA South Central Mental Illness Research, Education and Clinical Center (SC MIRECC) in Little Rock, Arkansas offers two year advanced fellowships. These interdisciplinary programs aim to train health care practitioners including psychiatrists, psychologists, pharmacists, nurses, and social workers to become outstanding clinical administrators or health services researchers in high priority areas of mental health.

The SC MIRECC fellowship includes two tracks: **Research** and **Clinical Administration**. Individuals on the research track are those who expect to develop primarily independent research careers. Individuals on the Clinical Administration track are those who view themselves becoming clinical leaders integrating rigor quality improvement methods into their leadership and working in clinical settings.

Individualized, mentored research, quality improvement, and clinical training are combined with a state-of-the-art curriculum. Fellows will be offered abundant opportunities to increase their experience and knowledge and develop a research career with mentoring from national experts.

The MIRECC fellowship in Little Rock is part of the national VA Special Fellowships Program. Each of the VA MIRECC fellowship sites, which are located across the US, are linked electronically for didactic, academic, and research efforts with didactic research training coordinated through a fellowship hub site located at the Palo Alto VA Medical Center.

## Research Focus Areas

- Alcohol use disorders
- Substance use disorders
- Suicide prevention
- Post traumatic stress disorder
- Moral Injury
- Trauma sequelae
- Health Equity
- Access and engagement to mental health care treatments

## Fellowship Training Goals

1. Provide fellows with excellent training in research or quality improvement (about 75% time) consisting of formal didactics in research design and methods and hands-on research mentoring by VA faculty, most of whom have appointments at the UAMS Department of Psychiatry and College of Public Health. Each fellow will initiate and complete at least one individual research or quality improvement project, including publishing results or a product from the study.
2. Place fellows in clinical settings appropriate to their research interests such that their clinical practice (at least 25% time) will complement and enhance their research training. Fellows will use an evidence-based approach to clinical care, treatment planning, and service delivery.
3. Offer fellows other opportunities to optimize their success in academic settings, such as career mentoring, grant writing and grantsmanship, technical writing, and training in research ethics.

## Fellowship Qualifications

Eligibility requirements for the MIRECC fellowship for physicians include\*:

1. Completed residency accredited by Accreditation Council for Graduate Medical Education or American Osteopathic Association or the Executive Committee of the Council on Postdoctoral Training;
2. Must have an active, unrestricted license to practice in the U.S.;
3. U.S. citizenship; International medical graduates must also have a current visa and an ECFMG certificate that is valid indefinitely. Applicants on a J-1 visa must have current ECFMG sponsorship.
4. A male applicant born after 12/31/1959 must have registered for the draft by age 26 to be eligible for any US government employment, including selection as a paid VA trainee;
