Stacy Belkonen & Katherine Luci (co-Pls); Brian Shenal, Laurel Riddle, Anita Kablinger (co-applicants) - Salem VAMC A Self-Help Lending Library for Veterans with Traumatic Brain Injury (TBI), Their Families, and Providers.

The creation of a resource lending library for Veterans with TBI, their families and their treatment providers is the goal of this proposal. Military-related TBI affects many aspects of the lives of Veterans and their family members. Associated problems can include cognitive impairments, emotional lability, behavioral issues, personality changes, limited function of arms or legs, and abnormal speech or language. This lending library will provide additional resources to help Veterans and their families learn more about TBI and how to cope with the effects that it can have in their lives.

John Lynch (PI); Brian Meyer, Scott McDonald (coapplicants) - Richmond VAMC *Impulse Control in PTSD Treatment*

The goal of this proposal is dissemination of a PTSD treatment model that emphasizes functional and adaptive coping skills. Service members and their families face significant challenges in readjusting from the highintensity of combat settings to life back at home in terms of day-to-day living. Early interventions in the treatment of PTSD help resolve initial problems and avoid development of more serious mental health conditions and psychosocial impairment. This PTSD treatment model addresses the need to improve day-to-day functioning quickly and effectively before treating trauma specific disorders. The emphasis is on impulse control as the key first step. Veterans get relief on an immediate basis and stabilize their current function. This approach builds self efficacy and helps Veterans learn that they have the skills, competency, and mastery to handle the problems and difficulties that daily life may bring.

Christi Ulmer (PI); Leah Farrell-Carnahan, Rachel Manber, Melanie Means (co-applicants) - Durham VAMC Self-Management Materials for Sleep Disturbance in Recently Deployed Veterans

The goal of this proposal is translation of an evidencebased cognitive-behavioral treatment for insomnia (CBTI) into a self-management workbook format. Sleep disturbance is one of the most common complaints among recently deployed Veterans. An astounding 64% report difficulty falling and staying asleep upon their return from deployment. CBTI, now recommended as a first line treatment for sleep disturbance, has several components: sleep restriction, stimulus control, cognitive restructuring, and relapse prevention. In combination, these components lead to improvements in sleep quality, time to fall asleep, and wake time after sleep onset. barriers to addressing Veterans' sleep complaints include availability of qualified providers and difficulty engaging this population in weekly clinic-based treatment due to conflicts with work, academic, and family obligations. This self-management workbook will allow Veterans to participate in treatment at a time and place of their own choosing. It is envisioned as the entry-level for a stepped care model of treatment for sleep disturbance in recently returned Veterans.

Debra Volkmer (PI); Amanda Vaughn (co-applicant) -Salisbury VAMC Resiliency Training for OEF/OIF/OND Service Members, Veterans, and Families

The goal of this proposal is to encourage resiliency and community reintegration in OEF/OIF/OND Veterans receiving case management. Resiliency training will be offered to both the Veteran and their spouse/significant other. The training will utilize existing educational materials and will be delivered via workbook and virtual group meetings (Webinar and/or conference call). This will allow the program hours to be structured to meet the individual needs of this unique population. The training will reinforce recovery through education, enhancing the Veteran's ability to acclimate back to civilian life by focusing on concepts and skills related to balance and resilience.

Group Supervision for Clinicians Listening to Trauma Histories

Therapists treating PTSD often find themselves in parallel turmoil, as they react to the patient's inner and outer worlds. Good clinical supervision is essential. In addition to receiving guidance and support from an experienced colleague, having the opportunity to share one's often turbulent emotions and learning how these can be used to better understand the case are also important.
